# **RESOLUTION NO. 39 S. 2017**

ADOPTING THE REPORT OF THE COMMITTEE ON LAWS, RULES AND REGULATIONS REGARDING THE ORDINANCE CREATING THE BATANGAS CITY MULTI-SECTORAL STI, HIV AND AIDS COUNCIL AND ITS TECHNICAL WORKING GROUP FOR THE PREVENTION AND CONTROL OF SEXUALLY TRANSMITTED INFECTION, HUMAN IMMUNODEFICIENCY VIRUS (HIV) AND ACQUIRED IMMUNE DEFICIENCY SYNDROME (AIDS), DEFINING ITS FUNCTIONS, PROVIDING RESPONSE, APPROPRIATING FUNDS AND OTHER RELATED PURPOSES"

**RESOLVED**, to adopt the report of the Committee on Laws, Rules and Regulations and the recommendations stated therein on Ordinance No. 19 S. 2016 entitled: "An Ordinance Creating the Batangas City Multi-Sectoral STI, HIV and AIDS Council and Its Technical Working Group for the Prevention and Control of Sexually Transmitted Infection, Human Immunodeficiency Virus (HIV) and Acquired Immune Deficiency Syndrome (AIDS), Defining Its Functions, Providing Response, Appropriating Funds and Other Related Purposes".

### **RESOLVED FURTHER,** to adopt the following amendments:

a. Section 5 (d) Powers and Functions shall be read as follows:

Organize and encourage owners/operators/managers of night entertainment establishments; massage parlors, sauna or any establishments that cater to adult entertainment, to actively participate in the prevention and control of STI, HIV and AIDS.

b. Section 12. Promotion of Prophylactics shall be read as follows:

To prevent STI and HIV infections, all entertainment establishments are required to make available and accessible prophylactics thereof such as other device that prevent transmission of HIV within their establishments.
