

**COMMENT / RECOMMENDATIONS:**

A scrutiny of the qualifications of Dr. Rene M. Colocar shows that he possesses the qualifications and none of the disqualifications for the office for which he is appointed.

The function of concurrence by the Sangguniang Panlungsod on the appointment is to determine whether the appointee possesses of all the qualifications and none of the disqualifications as provided by the Code, law or ordinance. Any arbitrary or whimsical withholding of the required concurrence despite the fact that the appointee is qualified, would amount to an encroachment into the prerogative of and discretion of the appointing authority.
