**RESOLUTION GRANTING THE REQUEST OF THE HONORABLE CITY MAYOR
BEVERLEY ROSE A. DIMACUHA FOR THE ABOLITION AND CREATION OF
POSITIONS IN VARIOUS OFFICES OF THE CITY GOVERNMENT OF BATANGAS**

WHEREAS, Section 455 of R.A. 7160 and Article 86 of its Implementing Rules and Regulations grant to the City Mayor the power to exercise general supervision and control over all programs, projects, services and activities of the city government, and in this connection shall have the power to appoint all officials and employees in the Executive Department. Corollary with this executive power is the power to create and abolish positions with the concurrence of the Sanggunian.

WHEREAS, the proposed creation of positions for different offices of the City Government of Batangas does not violate the forty-five percent (45%) Personal Services limitation cited in Section 325 of Republic Act. No. 7160, also known as the Local Government Code of 1991.

WHEREAS, the Honorable City Mayor in her letter, requested for the abolition and creation of various position titles due to efficient workforce and operation of the said offices to wit:




