**COMMITTEE REPORT**

**SUBMITTED BY :** THE COMMITTEE ON LAWS, RULES AND REGULATIONS

**SUBJECT :** Letter from the Honorable City Mayor, Beverley Rose A. Dimacuha requesting for the passage of a resolution adopting and approving the DRRM Trust Fund Plan and Program 2018 of the City Disaster Risk Reduction Management Council.

**COMMENTS:**

Referred to the Committee on Laws, Rules and Regulations is the above letter for study, comments and recommendation.

A hearing was conducted on March 22, 2018 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were Mr. Rodrigo Dela Roca of CDRRMC, Mrs. Marissa A. Serrano of City Budget Office, Mrs. Imelda H. Garcia and Mr. Federico R. Chavez both from City Accounting Office and Engr. Dwight Arellano of City Engineer's Office.

Section 12, Letter C (7) of R.A. 10121 ("Philippine Disaster Risk Reduction and Management Act of 2010") and Rule 6, Section 4 (8) of the Implementing Rules and Regulations of R.A. 10121, provide that the CDRRM shall "Prepare and submit to the local sanggunian through the LDRRMC and the LDC the annual LDRRMO Plan and Budget, the proposed programming of the LDRRMF, other dedicated disaster risk reduction and management resources, and other regular funding sources and budgetary support of the LDRRMO". What is required by the aforementioned law and its IRR is merely the submission of the annual LDRRMO Plan and Budget to the Sanggunian. Hence, the CDRRMO has already complied with the mandates of R.A. 10121.


**RECOMMENDATION:**


Finding the proposed plan and projects in accordance with law and responsive to the needs of Batangas City in terms of disaster risk reduction / protection, the Committee recommends:

1. The adoption of this Committee Report
2. The approval of the required Resolution hereto attached.


