COMMENT / RECOMMENDATIONS:

Referred to the Joint Committee on the Committee on Laws, Rules and Regulations and Committee on Civil Service was the above request for study, comments and recommendation.

A hearing was conducted on March 20, 2018 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were Dr. Macario B. Hornilla of OCVAS, Dr. Lorna L. Gappi of CLB and Ms. Aurea R. Castillo of HRMDO.

A scrutiny of the qualifications of Dr. Hornilla and Dr. Gappi shows that they possess the qualifications and none of the disqualifications for the office for which they are appointed.

The function of concurrence by the Sangguniang Panlungsod on the appointments is to determine whether the appointee is possessed of all the qualifications and none of the disqualifications as provided by the Code, law or ordinance. Any arbitrary or whimsical withholding of the required concurrence despite the fact that the appointee is qualified, would amount to an encroachment into the prerogative of and discretion of the appointing authority.
