Comments and Recommendations:

Referred to the Committee on Barangay Affairs for proper study, comment and recommendation:

Section 16 Chapter 2 of R. A. 7160 under its General Welfare clause that "Every local government unit shall exercise the powers expressly granted, those necessarily imlied there from, as well as powers necessary, appropriate, or incidental fo its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants".

Said ordinance prescribes the speed limit on vehicles traversing/travelling the roads within their territorial jurisdiction in an effort to promote the safety of drivers, passengers and pedestrians.

Finding no legal impediment and having shown its good intention to implement the subject ordinance, the committee hereby recommends:

- 2) Approval of the Barangay Ordinance
