

SUBJECT: BARANGAY ORDINANCE NO. 1, SERIES OF 2018 OF BARANGAY PAHARANG  
KANLURAN, BATANGAS CITY

MGA PAMPUBLIKONG LUGAR"**

**COMMENTS/RECOMMENDATIONS**

Referred to the Committee on laws, rules and regulations and the committee on barangay affairs for further study, comments and recommendations.

**Section 16 chapter 2 of R.A. 7160** under its General Welfare clause states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, **promote health and safety**, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

Said ordinance aims to promote the health and safety of the inhabitants of the Barangay by regulating, penalizing and prohibiting stray dogs within their territorial jurisdiction. Penalties are also provided for dog owners who in case of an incidence of dog bites or accidents refuse to provide medical assistance to bite victims or fail to comply with the regulations regarding responsible dog ownership.
