RESOLUTION REQUESTING THE CITY PUBLIC INFORMATION OFFICE TO PRODUCE AND DISTRIBUTE POSTERS CONTAINING EMERGENCY HOTLINES AND EVENTUALLY ENCOURAGING ALL ESTABLISHMENTS IN THE CITY OF BATANGAS TO POST THE SAID EMERGENCY HOTLINES IN A CONSPICUOUS AREA WITHIN THEIR PREMISES

WHEREAS, the public has recently been worried with the circulation of information that kidnapping activities are rampant again;

WHEREAS, parents fear for the safety and welfare of their children considering that they might be the next target of these criminals;

WHEREAS, news reports from different forms of media explained the modus of these criminals including possible targets and the reasons why they are doing such criminal activity;

WHEREAS, aside from criminalities, natural calamities are also inevitable due to changes in weather patterns and effects of climate change;

WHEREAS, during calamities, disasters and criminalities people sometimes do not know whom to call for assistance and help simply because they lack information about emergency response teams and their contact information;

WHEREAS, agencies of the government including local government units shall ensure the full protection of the welfare of its citizen as enshrined in our constitution and as provided for under RA 7160 or the Local Government Code of the Philippines;
