**RESOLUTION URGING THE BUREAU OF FIRE PROTECTION, DEPARTMENT
OF LABOR AND EMPLOYMENT AND CITY ENGINEERING SAFETY DIVISION
TO CONDUCT THE FIRE SAFETY OF SHOPPING MALLS AND MULTI-STOREY
COMMERCIAL BUILDING IN BATANGAS CITY**

WHEREAS, on Christmas Eve, a 32 hr. fire gutted New City Commercial Center Mall that tore through the shopping mall killing of 37 people in Davao City;

WHEREAS, seven days after, a fire engulfed Metro Department Store and Supermarket in Cebu City, fortunately without loss of life.

WHEREAS, malls and supermarket is a place for work, recreation and business, hence frequented by workers, children, old folks and entire families that become very important place in the community.

WHEREAS, there is a need for all malls and supermarket to ensure the compliance of the fire safety standards and building safety laws as required by the labour safety standards.

NOW THEREFORE, be it Resolved as it is hereby resolved, by the Sangguniang Panlungsod in session assembled to urge the Bureau of Fire Department, Department of Labor and Employment and CEO Building Official and CEO Safety Division, to conduct fire safety in all Shopping Malls, Supermarket and Multi-Storey Commercial Building in Batangas City.


