

Subject: Resolusyon bilang 03 serye 2018 ng Barangay Sta Clara, Lungsod ng Batangas na may pamagat na "Resolusyong Kagyat Na Pagbubuo ng Barangay Development Council"

COMMENTS/RECOMMENDATIONS:

Referred to the Committee on barangay affairs for further study, comments and recommendations.

As early as 1954, Barangay development councils were formed pursuant to Executive order #57 and in 1988 through an executive order number 319 from the late president Corazon Aquino

Section 305 of RA 7160 sets the Fundamental Principles regarding all financial transactions of the Local Government. Creation of a barangay development council is very important in realizing that the fiscal policies of the local government units may be realized and reconciled with local, national and regional plans. It also provides a venue for various stakeholders to proactively be involved in the development processes of Barangay Sta. Clara.

Given the important nature of the creation of the Barangay Development Council of Sta Clara, *it is deemed proper by this committee to promulgate a barangay ordinance and not merely a resolution so that the severity of its importance can be more emphasized*

Finding no legal impediment, the committee hereby recommends:

- 1) The Adoption of this committee report
- 2) Approval of the Barangay Resolution


