



### COMMITTEE REPORT

**TO: THE HONORABLE SANGGUNIANG PANLUNGSOD**

**FROM: THE COMMITTEE ON LAWS, RULES AND REGULATIONS**

**SUBJECT: MEMORANDUM OF AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES TO LAUNCH A SALARY LOAN FACILITY TO QUALIFIED OFFICERS AND EMPLOYEES OF THE CITY GOVERNMENT.**

The subject request for the grant of authority for the City Mayor to sign a Memorandum of Agreement (MOA) was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on September 18, 2018. The Committee held a hearing on September 24, 2018 and in attendance were the following:

From City Legal Office: Atty. Teodulfo Deguito; from City Planning and Development Office: Engr. Januario Godoy; from City Budget Office: Mrs. Elizabeth Delos Reyes; from City Accounting Office: Mrs. Sheryl Bool; from City Treasurer's Office: Mrs. Nila Petronila Olivario; from Human Resource Management and Development Office: Mrs. Aurea Castillo; and from DBP: Mrs. Maria Luisa Grimaldo and Ms. Niña Carmela Manlapaz. Also present are the Acting Chairman Coun. Sergie Rex M. Atienza and Committee members, Coun. Armando Lazarte, Coun. Gerardo Dela Roca and Coun. Julian B. Villena, the Vice Mayor Emilio Francisco A. Berberabe Jr. and other members of the Sangguniang Panlungsod Councilors Aileen Arriola Montalbo, Glenn M. Aldover, Hamilton Blanco, Oliver Macatangay, Nestor Dimacuha, and SK Federation President Marjorie A. Manalo.

#### FINDINGS:

During the committee hearing, the City Legal Officer made mentioned that there is nothing wrong with this agreement. However, he made mentioned of his important concern that the Budget, Treasurer and Accounting Officer should be vigilant to see to it that the employees still have a portion or a take-home pay despite of their existing loans. It was then supported by representative from DBP that they are considering a net take home pay of greater than P4, 000.00 for those who will make loan. Moreover, they made mentioned of the status of co-makers who will be suited only for those co-terminus positions and those who have an adverse findings online, meaning those who have previous cases of failure of paying debts or loans.


