**ASSIGNING SPECIFIC LOTS FOR THE USE OF THE INSTITUTION AS
PART OF ITS PROJECT DEVELOPMENT PLAN IN COMPLIANCE WITH THE
REQUIREMENTS OF CHED FOR THE RECOGNITION OF THE CLB
AS HIGHER EDUCATION (HEI)**

WHEREAS, in reference to the Office of the Institutional Quality Assurance and Governance (OIQAG) report on Colegio ng Lungsod ng Batangas, deficiency relative to its application for CHED recognition as Higher Education (HEI), CLB is required to submit a copy of the Sangguniang Panlungsod Resolution assigning specific lots for the use of the institution as part of its Project Development Plan;

WHEREAS, the perimeter area of CLB consisting of 6,780 square meters are hereby assigned for the exclusive use of the Colegio ng Lungsod ng Batangas with the Cadastral Lot 1013, Lot 129 and Lot 128 to be an integral part of this resolution;

WHEREAS, it is required that a resolution be passed by the Sangguniang Panlungsod to assign lots for the use of the said institutions.

NOW THEREFORE, be it resolved as it hereby resolves by the Sangguniang Panlungsod in session assembled to assign specific lots for the use of the institution as part of its Project Development Plan in compliance with the requirements of CHED for the recognition of the CLB as Higher Education (HEI).

COMMITTEE REPORT

TO: THE HONORABLE SANGGUNIANG PANLUNGSOD

FROM: THE COMMITTEE ON LAWS, RULES AND REGULATIONS

SUBJECT: RESOLUTION ASSIGNING SPECIFIC LOTS FOR THE USE OF THE COLEGIO NG LUNGSOD NG BATANGAS (CLB) AS PART OF ITS PROJECT DEVELOPMENT PLAN IN COMPLIANCE WITH THE REQUIREMENTS OF CHED FOR THE RECOGNITION OF THE CLB AS HIGHER EDUCATION (HEI).

The subject request for the passage of an ordinance was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on August 28, 2018. The Committee held a hearing on September 6, 2018 and in attendance were the following:

From City Legal Office: Atty. Teodulfo A. Deguito; from City Accounting Office: Mrs. Sheryl Bool; from City Budget Office: Mrs. Elizabeth Delos Reyes, from City Assessor's Office: Mrs. Guadalupe Judy Tumaming. Also present are the Chairman Coun. Alyssa Renee A. Cruz and Committee members Coun. Sergie Rex M. Atienza, Coun. Armando Lazarte, Coun. Gerardo Dela Roca and Coun. Julian B. Villena, and other members of the Sangguniang Panlungsod Councilors Aileen Arriola Montablbo, Glenn M. Aldover, Hamilton Blanco, Oliver Macatangay, Karlos Buted, Nestor Dimacuha, Nelson Chavez, Angelito Dondon Dimacuha and SK Federation President Marjorie A. Manalo.

FINDINGS and DISCUSSION:

During the committee hearing, the City Legal Officer clearly explained that the City Government cannot give any exclusive title to the Colegio ng Lungsod ng Batangas as it is also part of the City Government.

The Committee and other members of the Sangguniang Panlungsod advised the College Administrator to furnish the body copy of the school's perimeter area for the preparation of the required resolution.

With the view that this request will eventually be favorable to the City of Batangas especially to its inhabitants, the Sangguniang Panlungsod perceives the essentiality to pass a resolution on this effect.
