COMMITTEE REPORT

TO: THE HONORABLE SANGGUNIANG PANLUNGSOD
FROM: THE COMMITTEE ON LAWS, RULES AND REGULATIONS
SUBJECT: MEMORANDUM OF AGREEMENT BETWEEN COLEGIO NG LUNGSOD NG BATANGAS AND ARCZONE PROFESSIONAL DEVELOPMENT CENTER.

The subject request for the grant of authority for the City Mayor to sign a Memorandum of Agreement (MOA) was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on August 28, 2018. The Committee held a hearing on September 6, 2018 and in attendance were the following:

From Colegio ng Lungsod ng Batangas: Dr. Lorna L. Gappi and Mr. Andrew Brian Deguito; and from Arczone Professional Development Center: Dr. Arceli M. Amarles, Dr. Gina M. LOntoc and Ms. Jesusa F. Flores. Also present are the Chairman Coun. Alyssa Renee A. Cruz and Committee members Coun. Sergie Rex M. Atienza, Coun. Gerardo Dela Roca and Coun. Julian B. Villena, and other members of the Sangguniang Panlungsod Councilors Glenn M. Aldover, Karlos Buted, and SK Federation President Marjorie A. Manalo.

FINDINGS:

During the committee hearing, the College Administrator of the Colegio ng Lungsod ng Batangas (CLB) make an introductory statement regarding the Memorandum of Agreement. At present, CLB have 28 faculty members and more than 40 personnel (non-teaching). She also mentioned that those faculty members are required to earn 45 CPD units every 3 years and this units are also required by the Philippine Regulatory Commission before the renewal of license of those teachers.

Likewise, further information about the programs and services provided by Arczone Professional Development Center was discussed by its representative including the 15 years of existence of the said CPD provider and its core competencies as an accredited providers by the PRC and Civil Service Commission (CSC).

Concerns from the members of the Committee was focused on who will pay for the training of teachers, where the venue of training is, is there already programs/services

that are aligned to be given to teachers and what is the actual set-up of the agreement and how it will be provide to participants.


RECOMMENDATIONS:
