



AUGMENTATION OF APPROPRIATIONS OF VARIOUS OFFICES OF CITY GOVERNMENT OF BATANGAS

BACKGROUND:

The subject request for the passage of an ordinance was referred to the Committee on Appropriations for its consideration during the Regular Session on July 22, 2019 and July 30, 2019. The Committee held a hearing on August 1, 2019 and in attendance were the following:

Villena and Jackielou D. Ante; from CSWDO: Mrs. Mila Española and some of the Sangguniang Panlungsod employees. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and committee members Coun. COMMENTS:


