



SUBJECT : Proposed Legislative Agenda 2019-2022

As mandated by the Local Government Code of 1991 and the guidelines and Memorandum Circulars of the DILG, the Sangguniang Panlungsod held a public consultation on the priority areas of legislation for the purpose of formulating the Sangguniang Panlungsod's Legislative Agenda 2019-2022. The public consultation was held on July 30, 2019 and was attended by a multi-sectoral audience. The copy of the attendance record is attached as Annex "A".

Likewise, the Committee gathered the individual legislative thrusts of the members of the Sangguniang Panlungsod, outlined as their proposals for the next three years of their term.

The Committee reviewed, sorted, and collated the requests aired by the public and the proposals submitted by the members of the Sangguniang Panlungsod and came up with a Proposed Legislative Agenda 2019-2022. This proposed Legislative Agenda embodies the integrated aspirations of the members of the Sangguniang Panlungsod.

In view of the foregoing, the Committee recommends the adoption of the attached Legislative Agenda of the Sangguniang Panlungsod for 2019-2022.
