
NOW THEREFORE, be it resolved, as it hereby resolves, to endorse the establishment of Batangas City South Senior High School.



COMMITTEE REPORT

PROPOSED ESTABLISHMENT OF BATANGAS CITY SOUTH SENIOR HIGH SCHOOL

BACKGROUND:

The subject request for the passage of a resolution for the establishment of Senior High School was referred to the Committee on Education for its consideration during the Regular Session on June 17, 2019. The Committee held a hearing on August 5, 2019 and in attendance were the following:

From Department of Education, Batangas City: Mr. Jeffrey Pangan; from PSDS-District V: Mrs. Carmelita D. Abag; from Batangas City South Elementary School: Mrs. Amparo H. Perez and Mrs. Kazelyn D. Aguba. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and committee members Coun. Nestor Dimacuha, Coun. Isidra M. Atienza and SK Federation President Marjorie A. Mandalo, the Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod Councilors Oliver Macatangay, Nelson Chavez, Maria Aleth Lazarte and Lorenzo A. Gamboa Jr.

COMMENTS:

During the committee hearing, the representative from DEPED, Batangas City mentioned about the DepEd Order No. 51, S. 2015 stating the Establishment of Public Senior High Schools (SHS) to provide quality education to the Batangueños youth.

The proposed establishment of Senior High School is due to the reforms brought about by the K-12 curriculum, as the Batangas City South Elementary School has the capability of offering the said program.

FINDINGS:

The Batangas City South Elementary School representatives reiterated their intention to establish a stand-alone Senior High School since there is no public SHS in Poblacion which are composed of twenty four (24) barangays. Most Grade 10 completers from public schools has no capability to enroll in the private SHS due to financial constraint. Representatives from Batangas City South Elementary School manifested that there is actually enough buildable space for the establishment of the a Senior High School building and that classrooms in the ALS

building to accommodate the students during its initial year of operation while waiting for the construction of the building. Since, the Batangas City government has articulated its full support for this endeavor, it is for the same reasons that the Committee recommends the approval of the said request.
