RESOLUTION NO. 235 S. 2019

RESOLUTION FAVORABLY ENDORSING THE PROPOSED DEVELOPMENT OF AN I.T. BUILDING BY THE XRC MALL DEVELOPER INC., FOR PEZA REGISTRATION

WHEREAS, the Philippine Economic Zone Authority (PEZA) as a government-owned and controlled corporation and is attached to the Department of Trade and Industry, is committed to contribute to the accelerated generation of investments, exports and employment in the Philippines through effective management of public and private economic zones, efficient administration of incentives, utmost delivery of services, focused investment promotions and proactive conduct of development activities;

WHEREAS, Republic Act No. 7196 or the Special Economic Zone Act of 1995, as amended by Republic Act No. 8748, together with its Implementing Rules and Regulations, prescribes that prior to the endorsement of the subject area as Special Economic Zone, PEZA Board necessitates an endorsement of the Sangguniang Bayan/Panlungsod for the development of the proposed economic zone subject to the condition to wit:

I. To require all PEZA-registered enterprises entitled to PEZA incentives located within the territorial jurisdiction of Batangas City, whether or not they are duly accredited by the Batangas City Government to pay and remit directly to the Batangas City Treasurer the following fees per annum:

- II. To submit to the Office of the City Assessor of Batangas City sworn declaration of PEZA registered enterprises of their capital equipment, if any to include kind, purchase or acquisition cost, date of purchase/acquisition, date of operation, freightage, insurance and installation costs.
- III. To enforce compliance to Ordinance No. 8 S. 1994 entitled: "The Ordinance Providing Priority in Employment or Work to Qualified Barangay Residents" to all PEZA Registered or Non-PEZA registered enterprises including their Developers/Operators. Further, to require said enterprises, Developers/Operators to submit to the City Government the numbers and classifications of their employees and workers.

RESOLUTION FAVORABLY ENDORSING THE PROPOSED DEVELOPMENT OF AN I.T. BUILDING BY THE XRC MALL DEVELOPER INC., FOR PEZA REGISTRATION

WHEREAS, the XRC Mall Developer is expected to promote the flow of investments, both foreign or local, which is expected to generate employment opportunities thereby negating the effect it may have the city's revenue collection brought about by the fiscal incentives under Section 23 and exemptions from national and local taxes under Section 24 of R.A. 7916 as amended by R.A. 8748, which are granted by law to locators thereof;

WHEREAS, business establishments not registered under the Philippine Economic Zone Authority (PEZA) shall remain to be under the taxing jurisdiction of the City Government of Batangas;

NOW THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod of Batangas by virtue of the powers vested in it by law, in session assembled, to favorably endorse the Proposed Development of an I.T. Building at Xentro Mall Batangas City by the XRC Mall Developer Inc. for PEZA Registration subject to the following conditions:

- That whatever privilege granted by law shall only be extended to PEZA registered locators exclusively engaged in Information Technology (IT) Enterprises and related activities;
- 2. That the PEZA tax incentives shall only be applicable and be availed by PEZA registered enterprises/businesses engaged in international IT services in which PEZA committed to regularly provide an updated list to the City Government/Sangguniang Panlungsod.
- 3. XRC Mall Developer Inc., IT Locators and business enterprises within the IT Park shall provide the City Government of Batangas, every three (3) months a list of their manpower requirements, including the criteria for employment selection of prospective employees;
- 4. XRC Mall Developer Inc., IT Locators and business enterprises within the IT Park shall hire qualified residents of Batangas City for their manpower requirements in compliance to City Ordinance No. 8, Series of 1994 entitled "An Ordinance Providing Priority in Employment of Work to Qualified Barangay Residents on Business Establishment and Infrastructure Project Within the Territorial Jurisdiction of the Barangays Within Batangas City and Providing Penalties for Violation Thereof".
- 5. XRC Mall Developer Inc., IT Locators and business enterprises within the IT Park shall pay the Mayor's Permit fee on business or realty fees, and other fees and charges prescribed by the City Government of Batangas.
- 6. XRC Mall Developer Inc. must comply to the City Ordinance No. 16 Series of 2010 entitled: "An Act Providing for the Environment Code of Batangas City" otherwise known as the E-Code;
- 7. This endorsement may be withdrawn any time on the ground of non-compliance with any of the aforementioned terms and conditions.

SUBJECT : LETTER FROM MR. ALEXANDER M. CRUZ, XRC MALL DEVELOPER INC., REQUESTING ENDORSEMENT FROM THE CITY COUNCIL OF THEIR APPLICATION FOR PEZA REGISTRATION FOR THE DEVELOPMENT OF THE I.T. BUILDING AT XENTROMALL

BACKGROUND:

The subject request for the passage of a resolution was referred to the Joint Committee of the Committee on Laws, Rules and Regulations and Committee on Environment and Urban Development, Land Use and Zoning for its consideration during the Regular Session on July 22, 2019. The Committee held a hearing on April 8, 2019 and in attendance were the following:

Atty. Teodulfo Deguito from the City Legal Office; Mrs. Ditas A. Rivera from BPLO, Engr. Januario B. Godoy from CPDO; Mr. Emmanuel Cortero from PEZA; Mr. Mel Bayato representative of XRC Mall Developer Inc.; Mrs. Marissa C. Argente and Maria Carmen G. Garcia from DTI Batangas. Also present are the Chairperson of the Committee on Laws, Rules and Regulations Coun. Alyssa Renee A. Cruz and Chairperson of the Committee on Environment and Urban Development, Land Use and Zoning Coun. Gerardo A. Dela Roca, and the committee members Coun. Oliver Macatangay, Coun. Nelson Chavez and SK Federation President Marjorie A. Manalo. The other members of the Sangguniang Panlungsod, Councilors Aileen Grace A. Montalbo, Nestor Dimacuha, Karlos Buted, Julian Pedro M. Pastor, Isidra M. Atienza, Maria Aleth Lazarte and Lorenzo A. Gamboa Jr. and the Vice Mayor Emilio Francisco A. Berberabe Jr., were also present during the said committee hearing.

During the committee hearing, the representative from XRC Mall Developer Inc., Mr. Bayato explained and appealed to the Sangguniang Panlungsod for an endorsement for the development of an I.T. Center to be located at the back Xentromall, Batangas City.

He also mentioned that Philippine Economic Zone Authority (PEZA) has already certified and issued a Board Resolution No. 17-142 dated March 14, 2017 giving the XRC Mall developer Inc., a prequalification clearance for the approval of their request. One of the requirements for the approval of the site as an Information Technology Economic Zone is the favorable endorsement of the Sangguniang Panlungsod which has jurisdiction over the proposed site.

The area applied for by XRC Mall Developer Inc. and requested to be endorsed to PEZA conforms or is compatible to the prescribed particular use as per the City Planning and Development Officer.
