**DENOUNCING THE ATROCITIES/ACTIVITIES OF THE CPP/NPA/NDP
IN BATANGAS CITY**

WHEREAS, one of the major thrusts of the national government is to end communist armed conflict;

WHEREAS, past and recent history of the Philippines is sprayed with essays of rebellion and armed atrocities perpetrated by leftist groups such as the Communist Party of the Philippines, the New People’s Army, and the Nationalist Democratic Front, among others;

WHEREAS, similar incidents have occurred in the outskirts and rural barangays of Batangas City, and reports of sightings of leftist groups reach the Batangas City PNP and Government Officials;

WHEREAS, incidents of armed conflicts, or the mere presence of armed groups in Batangas City bring fear to the residents and destabilizes their normal socio-economic activities;

WHEREAS, Batangas City abhors and strongly denounces the presence and any activity of the communist groups and declares the CPP, NPA, NDF as persona non grata in Batangas City;


