COMMITTEE REPORT

PROPOSED ESTABLISHMENT OF HALIGUE SILANGAN NATIONAL HIGH SCHOOL

BACKGROUND:

The subject request for the passage of a resolution for the establishment of Senior High School was referred to the Committee on Education for its consideration during the Regular Session on August 20, 2019. The Committee held a committee meeting on August 27, 2019 and in attendance were the following:

From Haligue Silangan Elementary School: Mrs. Marydel B. Marasigan; from Barangay Haligue Silangan: Mr. Danilo Balmes. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and committee members Coun. Nestor Dimacuha, Coun. Julian Villena, Coun. Gerardo Dela Roca, Coun. Isidra M. Atienza and SK Federation President Marjorie A. Manalo. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod Councilors Oliver Macatangay, Nelson Chavez, Maria Aleth Lazarte and Lorenzo A. Gamboa Jr. were also present.

COMMENTS:

During the committee meeting, the representative from Haligue Silangan Elementary School reiterated that the proposed establishment of Secondary Junior High School at Haligue Silangan Elementary School will provide a free public Secondary Education to all the residents of Batangas City specifically, to cater students residing at Barangay Haligue Silangan, Haligue Kanluran, Cumba, Talahib Payapa and Maruclap.

The same also manifested that there is actually enough buildable space for the establishment of the said Secondary Junior High School building to be located at Haligue Silangan Elementary School.

Since, the members of the Sangguniang Panlungsod and the Batangas City government have articulated its full support for this endeavor, they inculcated that as long as this program is subject to the guidelines provided by the Department of Education (DEPED) and is included in the Batangas City Annual Investment Program (AIP), it is for the same reasons that the Committee recommends the approval of the said request.
