COMMITTEE REPORT

UTILIZATION OF A PORTION OF 30% CDRRMC QUICK RESPONSE FUND

BACKGROUND:

The subject request for the utilization of fund was referred to the Committee on Appropriations for its consideration during the Regular Session on August 20, 2019. The Committee held a hearing on August 28, 2019 and in attendance were the following:

From City Disaster Risk Reduction and Management Council: Mr. Rodrigo Dela Roca; representatives from City Health Office: Dr. Dandy Ian Niño Calingasan, Mrs. Susana Mira and Mrs. Aileen F. Cantos; and from City Accounting Office: Mrs. Imelda H. Garcia. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and the committee members Coun. Gerardo A. Dela Roca, Coun. Julian B. Villena, Coun. Oliver Z. Macatangay and Coun. Nelson Chavez. The Vice Mayor Hon. Emilio Francisco A. Berberabe Jr. and other members of the Sangguniang Panlungsod Councilors Nestor E. Dimacuha, Karlos Buted, Isidra M. Atienza, Maria Aleth Lazarte, Lorenzo A. Gamboa Jr. and SK Federation President Marjorie A. Manalo were also present.

COMMENTS:

During the committee hearing, the CDRRMC Officer made an introductory statement regarding the requested utilization of fund in compliance with the NDRRMC Memorandum Circular No. 01 S. 2019 or "Enjoining all Member Agencies to Support the Nationwide Dengue Epidemic Response".

As per the said memorandum, the said agencies are requested to have dengue-awareness campaigns, community participation through Dengue Brigades, and assistance in the mobilization of logistics and conduct of chemical interventions. As a result, it is necessary to utilize a portion of the 30% CDRRMC Quick response Fund amounting to P 15,000,000.00 in order to conduct the said activities which will be beneficial in combating the dengue threat.

The number of dengue cases from 2018 to 2019 increased from 696 (2018) to 991 cases as of January 1 to August 27, 2019. The representatives from the City Health Office reiterated there is no "outbreak" yet to consider since this declaration supports an environmental study, naval survey, laboratory confirmation and the like. The said 30% CDRRMC Quick Response Fund will be funded from the General Fund

and this was mainly intended for purchasing necessary equipments in support for misting activites, training personnel to be done by the City Health Office.

RECOMMENDATIONS:

Finding no legal impediment for the approval of the requested utilization, the Committee recommends the approval of request of the Honorable City Mayor.

In view of the foregoing, the Committee hereby recommends:

- 1. The adoption of this Committee Report.
- 2. The approval of an Ordinance hereto attached.
