GRANTING AUTHORITY TO THE CITY MAYOR HONORABLE BEVERLEY ROSE A. DIMACUHA, TO SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SM LIFESTYLE ENTERTAINMENT, INC. FOR FREE ADMISSION TO ALL SM CINEMA IN BATANGAS CITY OF SENIOR CITIZENS AND PWDs

WHEREAS, the Batangas City desires to provide additional privileges to Senior Citizens and Persons with Disability (PWDs) to make their lives more liveable and sociable;

WHEREAS, the Senior Citizens and PWDs of Batangas City received 20% discount stipulated under R.A. 7432, R.A. 9257, R.A. 9994 and R.A. 9442 and based on the sample computation for the agreed cost apportionment, the remaining 80% will be divided into two (2): 40% for SM Counterpart and 40% of the amount to be billed to the City Government of Batangas;

WHEREAS, in connection of the privilege herein granted to Batangas City Senior Citizens and PWDs, the City Government of Batangas agrees that the amount representing the fifty (50) percent balance between the actual admission price and the discount shall be exempt from the amusement tax;
