COMMITTEE REPORT

TO: THE HONORABLE SANGGUNIANG PANLUNGSOD

FROM: THE COMMITTEE ON APPROPRIATIONS

SUBJECT: RESOLUTION APPROVING THE PROPOSED APPROPRIATION PLAN OF THE COLEGIO NG LUNGSOD NG BATANGAS (CLB) FOR THE UNIFIED STUDENT FINANCIAL ASSISTANCE SYSTEM FOR TERTIARY EDUCATION (UNIFAST) FOR THE SEMESTER OF AY 2018-2019.

The subject request for the passage of a resolution approving the Appropriation Plan of the Colegio ng Lungsod ng Batangas for UNIFAST funding was referred to the Committee on Appropriations for its consideration during the Regular Session on February 6, 2019.

Last September 6, 2018, the Committee on Laws, Rules and Regulations held a committee hearing to discuss the granting of separate bank account with Land Bank of the Philippines to the Colegio ng Lungsod ng Batangas exclusively for UNIFAST Funding. It was then approved through Resolution No. 318 dated October 2, 2018 by members of the Sangguniang Panlungsod, Batangas City.
