The Committee on Environment, Urban Development, Land Use and Zoning held a Committee Hearing on March 6, 2019. In attendance are the following: Hon. Emilio Francisco Berberabe, Jr., Vice Mayor, Hon. Untalan from City Engineer's Office; Roselyn Berberabe and Delia M. Licarte from City Planning and Development Office.

This is an application for Special Use Permit for a Concrete Batching Plant project to be located in Barangay San Jose Sico, Batangas City. The project site is a property measuring 26,698 square meters located within the designated General Development Zone - 1 per the City Zoning Ordinance, accessible through the Batangas City-Lobo national road leading to the municipalities of Taysan and Lobo.

The batching plant project is of environmental and economic significance. Barangay San Jose Sico issued to the applicant a Resolution Allowing the Construction and Operate Concrete Batching Plant on Juy 9, 2018. An Environmental Compliance Certificate was already issued by the EMB-DENR to the Applicant for this project; and the City ENRO has likewise issued a City Environmental Certificate.

The applicant expressed its assurance to the City Government and to the barangay official present that the Company will install and maintain necessary measures to prevent the occurrence of health and environment hazards, not only for the residents of Barangay San Jose Sico but also for the workers inside the plant.
