



SUBJECT : SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2019 OF VARIOUS BARANGAYS.

**COMMENT / RECOMMENDATIONS:**

The supplemental budgets submitted for review contains the necessary documents and action taken by the Office of the City Budget Officer, as follows:

- (1) Certified Statement of Funding Sources, certified by the Brgy. Treasurer (Supplemental Budget Preparation Form No.1).
- (2) Statement of supplemental Appropriation (Objects of Expenditures) – prepared by the Barangay Treasurer and attested by the Punong Barangay (Supplemental Budget Preparation No.2).
- (3) Barangay Appropriation Ordinance approving the Supplemental Budget.
- (4) Letter of the Punong Barangay submitting the budget for review to the Sangguniang Panlungsod.
- (5) Stamped Mark of the preliminary review done by the Office of the City Budget Officer.
- (6) Letter of the City Budget Officer addressed to the SP recommending favorable action on the barangay Budget.

After a review of the said supplemental budgets pursuant to section 333 of the LGC of 1991 and Article 425 of the IRR, the Committee finds the supplemental budgets in accordance with law. Further, the aforementioned Supplemental Budget of Barangay Poblacion 04, Poblacion 05, Poblacion 07, Poblacion 13, Poblacion 15, Poblacion 16, Poblacion 17, Banaba East, Banaba West, Bolbok, Haligue Kanluran, Kumintang Ibaba, Mahabang Dahilig, Mahacot Kanluran, Mahacot Silangan, Malalim, Malitam, Maruclap, Pagkilatan, Pinamucan Silangan, Sampaga, San Agapito Isla Verde, San Agustin Silangan Isla Verde, San Miguel, Soro-Soro Karsada, Sto Domingo, Tabangao Dao, Talahib Pandayan, Talumpok Kanluran, Tinga Labac, Alangilan, Balagtas, Catandala, Cuta, Kumintang Ilaya, Libjo, Maapaz, Sirang Lupa, Talumpok Silangan, Tinga Itaas, Dela Paz Pulot Aplaya, all from Batangas City has passed the preliminary review by the City Budget Office and the same were favorably endorsed by the City Budget Officer.

In view of the foregoing, the Committee hereby recommends:

- (a) The adoption of the Committee Report; and
- (b) Approval of the resolution hereto attached.
