#### RESOLUTION NO. 28 S. 2020

A RESOLUTION EXPRESSING STRONG SUPPORT FOR THE IMMEDIATE PASSAGE OF H.B.5989, OR AN ACT SEEKING TO CREATE THE DEPARTMENT OF DISASTER RESILIENCE (DDR), DEFINING ITS MANDATE, POWERS AND FUNCTIONS, APPROPRIATING FUNDS THEREOF

WHEREAS, House Bill 5989 or An Act Seeking to Create the Department of Disaster Resilience (DDR), Defining its Mandate, Powers and Functions, Appropriating Funds Thereof was formally endorsed at the House of Representative 18<sup>th</sup> Congress last January 22, 2020 in the first-ever-out-of-town regular session held at Batangas City;

**WHEREAS**, the House approved draft H.B. 5989 on the DDR failed to hurdle the Senate before the 17<sup>th</sup> Congress closed in June 2019;

WHEREAS, the implementation of the DDR stands as the most critical of other pending disaster related measures as it could decide on matters involving disaster response at the highest levels of government and unify the currently fragmented disaster response mobilization of different agencies, among other functions;

WHEREAS, Batangas Province is currently devastated by the eruption of Taal Volcano and strongly believe that the creation of DDR is crucial to consolidate its disaster risk reduction effort and emergency response, mitigating the effect of future calamity and other natural disaster;
