

COMMITTEE REPORT

TO: THE HONORABLE SANGGUNIANG PANLUNGSOD
FROM: COMMITTEE ON APPOINTMENTS
SUBJECT: CONFIRMATION OF APPOINTMENT OF DR. LOYOLA C. BAGUI AS CITY
GOVERNMENT DEPARTMENT HEAD I IN THE OFFICE OF THE CITY
MARKET ADMINISTRATOR

COMMENTS:

The endorsement letter dated February 3, 2020 from the Office of the City Mayor Beverley Rose A. Dimacuha, forwarding to the Sangguniang Panlungsod ng Batangas the appointment papers of Dr. Loyola C. Bagui as Department Head I in the Office of the City Market Administrator, was referred to the Committee on Appointments chaired by Vice Mayor Emilio Francisco A. Berberabe, Jr., during the Regular Session last February 11, 2020.

A committee hearing was held on February 18, 2020 at 2:00 o'clock in the afternoon at the Sangguniang Panlungsod Session Hall. In attendance were the following:

From the Office of the City Market, Dr. Loyola C. Bagui; from Human Resource Management and Development Office, Mrs. Aurea R. Castillo; Committee on Appointments Chairperson, Vice Mayor Emilio Francisco A. Berberabe Jr.; Committee Members Coun. Alyssa Renee A. Cruz, Coun. Aileen Grace A. Montalbo, Coun. Nestor E. Dimacuha, Coun. Karlos Emmanjuel A. Buted, Coun. Gerardo A. Dela Roca, Coun. Oliver Z. Macatangay, Coun. Nelson J. Chavez, Coun. Julian B. Villena, Coun. Julian Pedro M. Pastor, Coun. Isidra "Ched" M. Atienza, Coun. Maria Aleth A. Lazarte, Coun. Lorenzo A. Gamboa, ABC President Angelito "DonDon" A. Dimacuha and SK Federation President Coun. Marjorie A. Manalo.

According to Dr. Loyola C. Bagui, cleanliness, orderliness, maintenance of Market III and repairs of Market I and II are the main concerns of the City Market Administration. To address the aforementioned issues, they scheduled a regular clean-up drive every Thursday; set up five (5) Divisions to be led by high ranking employees to focus on different aspect of the management of the City Market; recommends the issuance of citation tickets to enforce 'Eto Batangueño, Disiplinado Magkatuwang Tayo' program of the city government; and they are studying the feasibility of making issuance of cash ticket to be on a monthly basis instead of daily.

She also said that her eighteen (18) years of experience in government service, her belief of leading by example, her patience and God-fearing nature can be taken into consideration for the confirmation of her appointment.

During the discussion, the following concerns were raised by the members of the committee for the City Market Administration's attention:

- a. The problem of drainage system specially in the Fish Market Vendor's Section was cited by Councilor Gerry Dela Roca and request the City Market Administration to consider designing measures to address it;
- b. The traffic situation and available parking space especially during 'Huwebesan' was also a growing concern for many costumers according to Councilor Nestor Dimacuha and Councilor Julian Villena that needs immediate attention. Coordinating with the TDRO to help manage the traffic situation and consulting with the vendors for possible 'drop off' scheme to free-up parking spaces for the market goers was suggested;
- c. Councilor Nestor Dimacuha also urged the City Market Administration to prioritize the maintenance and cleanliness of the comfort rooms in the City Market, he also emphasized the importance of wearing a smile when dealing with the general public. Continuous monitoring and watching - out for unfair selling practices such as over pricing and fraudulent weighing scale;
- d. Councilor Julian Villena raised the issue of garbage collection problem. He also suggested to the City Market Administrator to conduct public consultations and hearings before implementing new policies and enforcing major management changes in the City Market. Giving priority to local vendors was also advocated;
- e. The concern over the displaced and side walk vendors was cited by Councilor Lorenzo Gamboa. Dr. Bagui assured the August body that there is a plan to accommodate them after the gradual transfer of those in temporary stalls were done.
- f. Councilor Nelson Chavez suggested to place utmost importance to security measures especially at night where various incidents of theft was reported. Installation of more CCTV will help in monitoring the activities within the City Market, as well as coordination with the host barangay to help in the peace and order situation.

Dr. Loyola Bagui stressed the contribution of the City Market as an income generating entity for the City of Batangas. She reported that the goal of being self-sufficient was reached by the Department, in this regard, she requested the city government to consider providing additional benefit or compensation like hazard pay and differential pay to the men and women who were relentless in their effort to achieve the said goal, working day and night even during holidays.

The Human Resource Management and Development Office represented by Ms. Aurea R. Castillo stated that upon their careful review and analysis and the comparative assessment done, Dr. Loyola C. Bagui met all the qualifications, trainings and eligibility required for the position she is being appointed to.

RECOMMENDATIONS:

Stated in Section 454 of the Local Government Code of 1991 that heads of departments shall be appointed by the City Mayor with the

concurrence of the majority of all the Sangguniang Panlungsod Members, subject to all civil service laws, rules and regulations.


A review of the qualifications of Dr. Loyola C. Bagui shows that she possess the qualifications and none of the disqualifications for the office for which she was appointed.

2. The approval of the Resolution hereto attached.


