RESOLUTION NO. 102 S. 2020

**AUTHORIZING THE CITY TREASURER TO ACCEPT PAYMENT OF TAXES, FEES
AND CHARGES AND OTHER PAYMENTS DUE TO THE CITY GOVERNMENT
THROUGH ELECTRONIC PAYMENT**

WHEREAS, the City Government of Batangas acknowledges the need to utilize alternative channels of payment of taxes, fees and charges, and other payments due to the City Government to facilitate efficient collection of payment for the good of the public service;

WHEREAS, several modes of payment are made available by technology, such as, but not limited to, G-Cash, Credit Card, Debit Card, PayMaya, PayPal and electronic fund transfer or direct payment to the City’s Fund Account;

WHEREAS, the City Treasurer needs authority to use these facilities;

NOW, THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to authorize, as it hereby authorizes the City Treasurer to accept payment of taxes, fees and charges, and other payments due to the City Government of Batangas thru G-Cash, Credit Card, Debit Card, PayMaya, PayPal and electronic fund transfer to Batangas City’s fund account;


FURTHER, the City Mayor is hereby authorized to enter into agreements with these providers of alternative modes of payment provided that terms and conditions of any such agreements entered into shall be lawfully beneficial to the City Government.


