WHEREAS, there is a need to secure for the people adequate supply of staples at affordable prices;

WHEREAS, the City Government taps the assistance of the National Food Authority to make available to the people of Batangas City sufficient supply of NFA rice;

NOW, THEREFORE, be it resolved, as it is hereby resolved, by the Sangguniang Panlungsod in session assembled, to authorize as it hereby authorizes the City Mayor Beverley Rose A. Dimacuha to enter into Agreement with the National Food Authority for the purchase of rice on cash or credit basis as provided in the Rice Sales Memorandum of Agreement attached as Annex "A" and made integral part of this Resolution.
