PASSAGE OF AN ORDINANCE ENTITLED "AN ORDINANCE PROVIDING FOR A MANDATORY PERSONAL ACCIDENT INSURANCE FOR ALL OUTBOUND SEAGOING PASSENGERS DOCKING IN PHILIPPINE PORTS AUTHORITY COMPOUND SITUATED IN BARANGAY STA. CLARA, CITY OF BATANGAS"

COMMENTS/RECOMMENDATIONS

The subject request for the passage of an ordinance was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on July 21, 2020 while its title were approved on the same date.

The Committee held a hearing on July 22, 2020 and in attendance were the following:

Representatives from City Health Office and BPLO Office. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and committee members Coun. Oliver Z. Macatangay and Coun. Nelson J. Chavez. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod were also present.

It is hereby the policy of the City Government to protect seagoing passengers docking in Philippine Ports Authority against any event or circumstance that can threaten one's health, life or limb and thus provide assurance of their safety and welfare. While, it shall be the duty of every shipping, whether operating as a common carrier or private charter, to provide personal accident insurance on all passengers in every boarded vessel.

Considering no legal impediment with the subject request and that the said request would be beneficial to the Batangas City government and its constituents, the Committee hereby recommends:

The adoption of this Committee Report.

2. The approval of the said Ordinance for Second and Final Reading in today's regular session.
