**WHEREAS**, a judicious review, evaluation and analysis of Barangay Bolbok SK, Batangas City Annual Budget submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved as it hereby resolves, to approve and declare operative the following Annual Barangay Budget for Calendar Year 2020 to wit:

1. Bolbok SK P 1,526,854.00

The budget documents shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.

This barangay budget is therefore considered operative and effective as of January 1, 2020 in accordance with Section 332 of R.A. 7160.
