Referred to the Joint Committees on Environment, Urban Development Land Use and Zoning and Engineering and Public Works is the application for zoning/locational clearance of SMART Communication, Inc. for the upgrading and conversion of its existing guyed tower to a forty-eight (48.0) meter high three-legged self-supporting tower/ cellsite located in Barangay San Agustin Kanluran, Isla Verde, Batangas City.

The project site is within the designated Agricultural Development Zone (ADC) per the Batangas City Zoning Ordinance. The Sangguniang Barangay of Barangay San Agustin Kanluran, Isla Verde, Batangas City issued Resolution No. 24 S. 2019 allowing the upgrading and conversion of the existing guyed tower/cellsite into a 48.0 meter high three legged self-supporting tower/cellsite in their barangay.

Other national agencies concerned such as Department of Health Food and Drug Administration, National Telecommunication Commission (NTC), Civil Aviation Authority of the Philippines (CAAP) and DENR-Environment Management Bureau CALABARZON, all issued respective clearances in favor of the proposed project.

RECOMMENDATIONS:

The Committee finds no legal impediment for the approval of the instant application for Zoning/Locational Clearance of SMART Communication, Inc., therefore the Committee recommend its approval subject to compliance to all applicable laws and Batangas City ordinances most specially, the Batangas City Environment Code, and health, safety, and general welfare ordinances.
