**RESOLUTION NO. 220 S. 2020**

**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG  
KABATAAN SUPPLEMENTAL BUDGETS OF VARIOUS BARANGAYS OF  
BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of each of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amount were appropriated:

1. Poblacion 23 SK	P 108,635.70
2. Tabangao Ambulong SK	2,578,322.11
3. Pallocan East SK	1,039,350.46

**RESPONSIBILITY.** The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.

**COMPLIANCE.** Compliance to the provisions of Joint Memorandum Circular No. 1 S. 2019 or the Guidelines on the Appropriation, Release, Planning and Budgeting Process of Sangguniang Kabataan (SK) Funds of the Department of Budget and Management, Department of Interior and Local Government and National Youth Commission and to all auditing rules and regulations are hereby mandated.


Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.

*SUPPLEMENTAL BUDGET FOR CY 2020 OF VARIOUS SANGGUNIANG KABATAAN (SK) IN  
THE CITY OF BATANGAS*

**COMMENTS / RECOMMENDATIONS:**

The supplemental budgets submitted for review contains the necessary documents and action taken by the Office of the City Budget Officer, as follows:

- 1) Letter of the SK Chairman submitting the proposed SK Supplemental Budget to the Sangguniang Panlungsod Members for approval.
- 2) Resolution approving the SK Supplemental Budget of various barangays certified by the SK Secretary and SK Treasurer and approved by the SK Chairman.
- 3) Certified Statement of Funding Sources, certified by the SK Treasurer and City Accountant and attested by the SK Chairman (Supplemental Budget Preparation Form No. 1).
- 4) Statement of Supplemental Appropriations (Objects of Expenditures)- prepared by the Barangay SK Treasurer and approved by the SK Chairman (Supplemental Budget Preparation Form No. 2)
- 5) Sangguniang Kabataan Supplemental Investment Program (SIP) by Program/Project/Activity by Sector of various barangays prepared by SK Secretary and SK Treasurer and attested by the SK Chairman.
- 6) Sangguniang Kabataan Supplemental Procurement Plan for FY 2020 of various barangays prepared by SK Secretary, recommended by the Chairman, Committee on Appropriation and approved by the Punong Barangay.
- 7) Sangguniang Kabataan Supplemental Procurement Management Plan (SPMP) of various barangays prepared by SK Secretary and approved by the SK Chairman.
- 8) Certification from the City Accountant certifying the amount as unexpected balance of the Sangguniang Kabataan Fund for 2019.
- 9) Comprehensive Barangay Youth Development Plan (CBYDP) for year 2019 of various barangays prepared by all members of the Sangguniang Kabataan and approved by the Punong Barangay.

As a review of the said Sangguniang Kabataan Supplemental Budgets pursuant to Section 20 of R.A. 10742 otherwise known as the "Sangguniang Kabataan Reform Act of 2015", the Committee finds the said budget in accordance with law. Further, the aforementioned Sangguniang Kabataan Supplemental Budgets of Barangays Poblacion 23, Tabangao Ambulong and Pallocan East, all of Batangas City have passed the preliminary review by the City Budget Office and the same were favorably endorsed by the City Budget Officer.
