RESOLUTION NO. 226 S. 2020

APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2020 OF BARANGAYS POBLACION 10 AND POBLACION 20, BOTH OF BATANGAS CITY

WHEREAS, a review of the Supplemental Budgets for Calendar Year 2020 of Barangays Poblacion 10 and Poblacion 20, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budgets for Calendar Year 2020 for the purpose the amount were appropriated:

1. Poblacion 10	P 271,592.89
2. Poblacion 20	352,063.04

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.
