TABANGAO APLAYA, BOTH OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of Sangguniang Kabataan Annual Budget of Barangays Sto. Niño and Tabangao Aplaya, both of Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Annual Sangguniang Kabataan Budgets for Calendar Year 2020 to wit:

These Sangguniang Kabataan budgets are therefore considered operative and effective as of January 1, 2020 in accordance with Section 332 of R.A. 7160.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
