**A RESOLUTION ADOPTING DEPARTMENT OF LABOR AND EMPLOYMENT
(DOLE) AND DEPARTMENT OF TRADE AND INDUSTRY (DTI) JOINT
MEMORANDUM CIRCULAR NO. 20-04 AND DEPARTMENT OF
TRANSPORTATION (DOTr) MEMORANDUM CIRCULAR 2020-014, REQUIRING
THE USE OF FACE SHIELDS IN ALL PUBLIC TRANSPORTATION AND IN ALL
WORKPLACES**

WHEREAS, in Accordance to Joint Memorandum Circular No. 20-04-A or the “DTI and DOLE Supplemental Guidelines on Workplace Prevention and Control of COVID-19”, the use of face shields aside from face masks shall be complied in all workplaces, regardless of economic activity;

WHEREAS, on 03 August 2020, the Department of Transportation (DOTr) issued Memorandum Circular No. 2020-014 requiring the mandatory use of face shield for all passengers in areas where public transportation is allowed;

WHEREAS, face shields must completely cover the sides and lengths of the face, as prescribed by the World Health Organization (WHO);

WHEREAS, the wearing of face shields shall be accompanied by other preventive measures against COVID-19, such as the mandatory wearing of facemasks, physical distancing and handwashing;


WHEREAS, provisions for minimum public health standards for wearing face shields if possible is effective to private employers with no cost to their employees;

NOW, THEREFORE, be it resolved, as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to adopt the Department of Labor and Employment (DOLE) and Department of Trade and Industry (DTI) Joint Memorandum Circular No. 20-04 and Department of Transportation (DOTr) Memorandum Circular 2020-014, requiring the use of face shields in all public transportation and in all workplaces.
