**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
ANNUAL BUDGET FOR CALENDAR YEAR 2020 OF BARANGAY SAN AGAPITO,
ISLA VERDE, BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of Sangguniang Kabataan Annual Budget of Barangay San Agapito, Isla Verde, Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Annual Sangguniang Kabataan Budget for Calendar Year 2020 to wit:

1. San Agapito Isla Verde SK Php 268,557.00

The budget documents shall form part of the authorized Sangguniang Kabataan budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.
