**RESOLUTION NO. 243 S. 2020**

**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG  
KABATAAN SUPPLEMENTAL BUDGET OF BARANGAYS MALITAM,  
STO. NIÑO AND TABANGAO APLAYA, ALL OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amount were appropriated:

1. Malitam SK	Php 662,950.16
2. Sto. Niño SK	890,066.41
3. Tabangao Aplaya SK	351,925.56

**RESPONSIBILITY.** The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.



Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
