**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
ANNUAL BUDGETS FOR CALENDAR YEAR 2020 OF BARANGAYS POBLACION 08,
BANABA WEST AND SAN AGUSTIN SILANGAN, ISLA VERDE,
ALL OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of Sangguniang Kabataan Annual Budgets of Barangays Poblacion 08, Banaba West and San Agustin Silangan, Isla Verde, all of Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Annual Budgets for Calendar Year 2020 to wit:

1. Poblacion 08-SK	Php 220,285.00
2. Banaba West-SK	404,078.00
3. San Agustin Silangan, Isla Verde-SK	227,883.00

The budget documents shall form part of the authorized Sangguniang Kabataan budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.


