WHEREAS, as mandated by R.A. 7160 or the Local Government Code of 1991, the City Development Council shall formulate and approve the City Annual Investment Program (AIP) including City Supplemental Annual Investment Programs;

WHEREAS, the priority programs and projects included in the Batangas City Supplemental AIP No. 1 for FY 2020 are in consonance with the sectoral goals and objectives of the Batangas City Comprehensive Development Plan CY 2019-2025;

WHEREAS, the Batangas City Supplemental AIP No. 1 FY 2020 includes priority projects to address and manage the effects of COVID-19 pandemic and other social, economic, infrastructure, disaster risk reduction and development activities which gear toward the realization of the city development vision;

WHEREAS, the funds that will be used to finance the implementation of the identified programs and projects listed in the Batangas City Supplemental AIP No. 1 for FY 2020 will be sourced out from unutilized appropriations, savings and other external sources such as the Bayanihan Grant to Cities and Municipalities (BGCM) from the national government and other lending institutions;

SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 (AIP) FOR FY 2020 OF THE CITY GOVERNMENT OF BATANGAS

BACKGROUND:

The subject request for approval and authorization of the said Supplemental Annual Investment Program No. 1 (AIP) for FY 2020 of the City Government of Batangas was referred to the Committee on Appropriations for its consideration during the Regular Session on September 7, 2020. The Committee held a hearing on September 14, 2020 and in attendance were the following:
