UNANIMOUSLY APPROVED.



COMMITTEE REPORT

PROPOSED ORDINANCE REQUIRING THE INSTALLATION OF TIP BOXES INSIDE PASSENGERS UTILITY VEHICLES (PUVs) AND TRICYCLES IN BATANGAS CITY

COMMENTS/RECOMMENDATIONS

The subject request for the passage of an ordinance was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on July 28, 2020.

The Committee held a virtual hearing on September 7, 2020 and in attendance were the following:

From TDRO: Engr. Francis Beredo, from City Budget Office: Mr. Manolo M. Perlada and from Batangas Transport Cooperative (BATRASCO): Mr. Leodigario Geron. Also present are the Chairperson Coun. Alyssa Renee A. Cruz and committee members Coun. Gerardo Dela Roca, Coun. Oliver Z. Macatangay, Coun. Nelson J. Chavez and Coun. Julian Villeva via Zoom. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod were also present.

While we are still under the diverse effects of the current COVID 19 pandemic, this ordinance will protect, enhance and alleviate the economic situation of Public Utility Vehicles (PUVs) drivers including jeepney and tricycle drivers.
