## COMMENTS/RECOMMENDATIONS

The subject request for the passage of an ordinance was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on July 28, 2020.

The Committee held a virtual hearing on September 7, 2020 and in attendance were the following:
