KARSADA, SAN ANTONIO, ISLA VERDE AND WAWA, ALL OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of Sangguniang Kabataan Annual Budgets of Barangays Sta. Rita Karsada, San Antonio, Isla Verde and Wawa, all of Batangas City submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Annual Budgets for Calendar Year 2020 to wit:
