**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG  
KABATAAN SUPPLEMENTAL BUDGETS OF BARANGAYS POBLACION 8 AND  
BANABA WEST, BOTH OF BATANGAS CITY**

**WHEREAS**, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amount was appropriated:


**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG
