RESOLUTION NO. 272 S. 2020

**APPROVING AND DECLARING OPERATIVE THE 2020 SANGGUNIANG
KABATAAN SUPPLEMENTAL BUDGETS OF BARANGAYS SAN AGUSTIN
SILANGAN ISLA VERDE AND STA. RITA KARSADA, BOTH OF BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of the Sangguniang Kabataan Supplemental Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Sangguniang Kabataan Supplemental Budgets for the purpose the amount was appropriated subject to the following condition as mention thru subsidiary motion by Councilor Nestor Dimacuha that:

1. The SK Barangay Supplemental Budget shall comply with DILG Circular No. 2020-074 and Local Budget Circular No. 124.
2. Disbursement of SK Budget and Barangay shall not be allowed for Non-Compliance of those mentioned Memorandum and Local Budget Circular.

 - b. Sta. Rita Karsada 5,027,050.50

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.



EFFECTIVITY. The approved Sangguniang Kabataan Supplemental Budgets shall take effect upon approval by the Sangguniang Kabataan concerned or on the date fixed in the Sangguniang Kabataan Ordinance as provided in Section 20 of R.A. 10742.

UNANIMOUSLY APPROVED by the Sangguniang Panlungsod on September 22, 2020.


