**RESOLUTION APPROVING THE BATANGAS CITY LOCAL DEVELOPMENT
INVESTMENT PROGRAM (LDIP) FOR CALENDAR YEAR 2019-2022**

WHEREAS, the Local Development Investment Program (LDIP) is a document that translates the Comprehensive Development Plan (CDP) into a process wherein programs, projects and activities (PPAs) were further defined and prioritized for funding in the annual general fund budget or through special fund generation schemes;

WHEREAS, the legal basis of the preparation of the LDIP is discussed in the Joint Memorandum Circular No. 001 Series of 2007 issued by the DILG, NEDA, DBM and DOF which details the Harmonization of Local Planning, Investment Programming, Revenue Administration, Budgeting and Expenditure Management, Joint Memorandum Circular No. 2015-01 Series of 2015 on the Revised Guidelines for Tagging/Tracking Climate Change Expenditures in the Local Budget, and the Local Budget Memorandum (LBM) No. 74, dated June 15, 2016;

WHEREAS, the preparation of the LDIP aims to establish the plan budget link by rationalizing the process of PPA selection and prioritization through analyzing the city’s fiscal status;



COMMENTS/RECOMMENDATIONS

The subject request for the passage of a resolution was referred to the Joint Committee on Laws, Rules and Regulations and Committee on Peace & Order and Public Safety for its consideration during the Regular Session on September 15, 2020.

The Committee held a hearing on September 24, 2020 and in attendance were the following:

From City Planning and development Office (CPDO): Engr. Norberto Carandang and Mrs. Gilda L. Godoy. Also present are the Chairperson Coun. Alyssa Renee A. Cruz of the Committee on Laws, Rules and Regulations and committee members Coun. Gerardo A. Dela Roca, Coun. Julian Villena, Coun. Oliver Z. Macatangay and Coun. Nelson J. Chavez. The Vice Mayor Emilio Francisco Berberabe Jr. and other members of the Sangguniang Panlungsod were also present.

During the committee hearing, representative from CPDO made mentioned that the preparation of the Local Development Investment Program (LDIP) aims to establish the plan budget link by rationalizing the process of Programs/Projects/Activities (PPAs) selection and prioritization through analyzing the city's fiscal status. The said program also translates the City Comprehensive Development Program (CDP) into a process wherein the said PPAs were further defined and prioritized for funding.

More so, this program shall be operationalized annually by the City Annual Budget and City Annual Investment Program (AIP) and shall have a time frame of at least three (3) years.

Finding the proposed program in accordance with law and responsive to the needs of Batangas City, the Committee hereby recommends:
