**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET FOR

WHEREAS, a review of the Supplemental Budget for Calendar Year 2020 of Barangay Poblacion 02, Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991;

NOW THEREFORE, be it resolved, as it hereby resolves, to approve and declare operative the Supplemental Budget for Calendar Year 2020 for the purpose the amount was appropriated:


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.
