WHEREAS, Section 444 (1) (vi) of Republic Act 7160 or the Local Government Code of 1991 provides that the City Mayor as a Chief Executive of the city government, upon authorization by the Sangguniang Panlungsod, shall represent the City in all its business transactions and sign on its behalf all bonds, contracts and obligation, and such other documents made pursuant to law ordinance:

WHEREAS, the DICT, in line with its mandate, aims to bridge the digital divide to enhance socio-economic condition providing inclusive growth to the country by establishing, Tech4ED Centers under its eFilipino-Technology for Economic Development Project and by Implementing the DigitalJobsPH trainings (DJT) Program under the DigitalPH initiative;

WHEREAS, the Batangas City Government has manifested its intent to establish a Tech4ED Center and has correspondingly attested to support all activities to sustain and maintain the Center to provide where and when feasible necessary services to the community;
