**APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN
ANNUAL BUDGETS FOR CALENDAR YEAR 2020 OF DIFFERENT BARANGAYS OF
BATANGAS CITY**

WHEREAS, a judicious review, evaluation and analysis of different Sangguniang Kabataan Annual Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the following Sangguniang Kabataan Annual Barangay Budgets for Calendar Year 2020 to wit:

1. Banaba Ibaba	PhP 370,345.00
2. Liponpon Isla Verde	221,289.00
3. Mahabang Dahilig	275,721.00
4. San Jose Sico	487,353.00
5. Paharang East	262,461.00

The budget documents shall form part of the authorized barangay budget.

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.

These Sangguniang Kabataan budgets are therefore considered operative and effective as of January 1, 2020 in accordance with Section 332 of R.A. 7160.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
