APPROVING AND DECLARING OPERATIVE THE SANGGUNIANG KABATAAN SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2020 OF DIFFERENT BARANGAYS OF BATANGAS CITY

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Sangguniang Kabataan (SK) Chairman.

COMPLIANCE. Compliance to the provisions of Joint Memorandum Circular No. 1 S. 2019 or the Guidelines on the Appropriation, Release, Planning and Budgeting Process of Sangguniang Kabataan (SK) Funds of the Department of Budget and Management, Department of Interior and Local Government and National Youth Commission and to all auditing rules and regulations are hereby mandated.

EFFECTIVITY. The approved Sangguniang Kabataan Supplemental Budgets shall take effect upon approval by the Sangguniang Kabataan concerned or on the date fixed in the Sangguniang Kabataan Ordinance as provided in Section 20 of R.A. 10742.

Certified copy of this resolution shall immediately be furnished to the Sangguniang Kabataan, through the Punong Barangay and to the City Budget Officer.
