WHEREAS, a judicious review, evaluation and analysis of each of the Barangay Annual Budgets submitted to the Sangguniang Panlungsod shows substantial compliance with law and all budgetary rules and regulations.

NOW THEREFORE, be it resolved as it hereby resolves, to approve and declare operative the following Annual Barangay Budgets for Calendar Year 2021 to wit:

Any change in the annual budget shall be in accordance with the provisions of Sections 321 and 336 of the Local Government Code.

Compliance with all existing laws, auditing rules and regulations are hereby mandated and shall be the responsibility of the barangay officials.

These barangay budgets are therefore considered operative and effective as of January 1, 2021 in accordance with Section 332 of R.A. 7160.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangays, through the Punong Barangay and to the City Budget Officer.
